

Junction Fair Sports Star of the Day Awards Terms and Conditions

Information on how to register and take part in the Sports Star of the Day Awards forms part of these terms and conditions.

1. Registration in the "Sports Star of the Day Awards" is open to not-for-profit junior sporting clubs located within 5kms of Junction Fair Shopping Centre.
2. Junior sporting clubs include any sports club with children up to the age of 12 years.
3. Acceptance in this program is not automatic. Junction Fair has 900 certificates available in 2022 and will select participating junior sporting clubs on a first served basis.
4. Registration is open until all certificates are exhausted.
5. Upon acceptance each junior sporting club will receive a supply of "Sports Star of the Day Award" certificates. Each certificate has a tear off Treat Voucher which can be redeemed at participating Junction Fair stores. Junior sporting clubs must ensure that their club's name is listed on both sections of the certificate.
6. As part of this program, junior sporting clubs will have the chance to win 1 of 2 \$1000 Cash Sponsorships thanks to Junction Fair Shopping Centre.
7. The total value of prizes awarded will be \$2000 cash.
8. The Club Competition will run from 14 March 2022 until 14 November 2022.
9. Centre Management will collect all redeemed Treat Vouchers from participating retailers during the promotional period and conduct the random draws as follows:
 - i. After 9am Monday 11 July 2022 - \$1000 Cash Sponsorship
 - ii. After 9am Monday 14 November 2022 – \$1000 Cash Sponsorship
10. In the event that the winning club does not contact Junction Fair within 14 days to claim their prize we will assume that the prize is unclaimed, a new club winner will be selected at random after 9am 25 July 2022 and 28 November 2022 respectively.
11. The Winning club will be published on the Junction Fair Shopping Centre Facebook Page after the club representative has been contacted on the day of the draw.
12. Judge's decision is final and no correspondence will be entered into.
13. The winning sporting club(s) will be required to liaise with the Centre Management Office, providing a tax invoice for payment of their cash sponsorship prize. The prize can only be taken as supplied and cannot be exchanged or modified.
14. The winning sporting club agrees to acknowledge Junction Fair Shopping Centre as a contributor/sponsor of the sporting club for the relevant season.
15. The winning sporting club will provide Junction Fair Shopping Centre with regular updates during the relevant season, these will be posted on the Junction Fair Shopping Centre social media channels.
16. All winners acknowledge that they will be required by Junction Fair Shopping Centre to participate in a photo opportunity and acknowledge that the photographs will be used for promotional purposes including appearing on social media and in centre signage.
17. Junction Fair Shopping Centre may, subject to State regulations, change entry criteria, terms and conditions and terminate this competition at any time at its absolute discretion without liability to any contestant or other person.
