Not-for-profit organisations must carry out work or assist locals within the following postcodes: 2251, 2289, 2291, 2292, 2294, 2298, 2299, 2300, 2302, 2303. They are not required to have an address within the postcodes mentioned.
- 4. Applicants will be required to choose four stores in which they would like to spend \$250 in gift vouchers. The Community Champions Grant will be provided on this basis to the recipient. Gift Vouchers cannot be swapped or exchanged for cash at a later date.
- 5. If an application has not been submitted in accordance with these terms and conditions Junction Fair reserves the right to verify the validity of any application and to disqualify any application that is forged, manipulated, or tampered with during the application process.
